Furthermore, none of the Released Parties shall be liable to the Undersigned Individual(s), club member, any guest, visitors or invitees of the forgoing, or to any other person, for damage to person or property due to defects or hazards in or on the property identified as Hill Country Bowhunters range, regardless of whether or not any defect or hazard may be attributed to negligence of any of the Released Parties. The Undersigned Individual(s) accepts the Range as suitable for its purposes, accepts the duty and obligation to inspect the property and waives defects or hazards therein and agrees to hold the Released Parties harmless from all claims for any damage.

Upon signature of this form, you accept the agreement above and acknowledge that you have read, understand and agree to the Rules of the Range as outlined below.

RULES OF THE RANGE

The following rules are intended to promote safe and fun archery competitions consistent with HCB's obligations to the property owner and to conform with applicable law. The goal is to have fun with archery in a family friendly environment. Please remember that there are often children around during our events and conduct yourselves accordingly.

1. No Firearms are allowed on the property.
2. No consumption or possession of alcoholic beverages is allowed on the property. HCB has and will exercise the right to ask anyone who appears to be impaired by alcohol or drugs to leave any tournament.
3. No smoking on the property except in designated areas. None of these designated areas are located on the tournament course.
4. The combination to the gate **must not be given to anyone**. This is a paid Full Membership privilege only.
5. No broad heads may be used.
6. No hunting is allowed on the property.
7. No overnight camping is allowed on the property.
8. No illegal activities are allowed on the property.
9. The gate must be closed at all times; there are cows on the property, so please do not leave the gate open any longer than necessary to pass through it.
10. No containers or trash (including cigarette butts) will be left on the range: please use the trash cans provided.
11. Vehicles must remain in designated parking areas. If special transportation provisions are needed, please consult an acting officer.
12. All minors on the property must be in the presence and active oversight of a responsible adult.
13. No trees will be cut, removed, or impacted in any way without specific written permission from the Lessor.
14. **Violation of any of these Range Rules may be grounds for your removal from the range, revocation of your membership or both.**

HCB reserves the right to alter or amend the Range Rules at any time during the membership year.
